### **Center for Medicaid Services Free Technical Assistance**

#### Person-Centered Practices Support

The National Center on Advancing Person-Centered Practices and Systems (NCAPPS) provides technical assistance on person-centered practice.

NCAPPS currently provides free short-term direct technical assistance to states working to implement person-centered planning consistent with the Home and Community-Based Services (HCBS) Final Rule.

CMS has contracted with New Editions Consulting, Inc., to offer TA to states on the various authorities available, 1915(c), (i), (j), and (k), and how to prepare your submissions to CMS. This TA is at no cost to the state.



### **Vocational Rehabilitation**

- The federal government gives grants to state agencies for vocational rehabilitation (VR) services.
- These grants support services to help individuals with disabilities prepare for and engage in employment.
- Many states have not been able to fully utilize their dollars.

Partner with VR Agency

- Ensure VR counselors and community-based employment service providers possess competencies to effectively support job seekers with BI
- Establish and increase the availability of Supported • Employment Services for people with BI
- Implement an evidence-based screening tool for lifetime • history of BI to identify and support people with BI
- Address specific needs for successful employment strategies
- Support peer mentoring from others with brain injury
- Increase the availability of job retention services for people • with BI who are already employed but may avoid job loss or may achieve advancement opportunities with the right **BI-related supports**
- Create additional Pre-Employment Transition Services geared towards encouraging school aged youth with BI to prepare and seek employment



# Ways to Partner with Vocational Rehabilitation

#### Nebraska has:

- Ensured that all VR counselors possess competencies to effectively support job seekers with BI
- Increased the availability of Supported
  Employment Services for job seekers with TBI.
- Implemented a universal approach to applying an evidence-based screening tool for lifetime history of brain injury to identify specific needs for successful employment strategies and aid in augmented data collection related to prevalence of TBI.

## **Opioid Settlement Dollars**

Every State is getting dollars for Opioid Settlement. States are required to spend at least 70% of their share on future opioid remediation, including to:

- Expand warm hand-off services to transition to recovery services
- Broaden scope of services for cooccurring substance use disorder/ mental health conditions
- Provide comprehensive wrap-around services to individuals in recovery
- Hire additional social workers or other behavioral health workers to facilitate expansions above •
- Provide evidence-based treatment and recovery support, including for co-occurring conditions and transitioning out of  $\bullet$ the criminal justice system



**OPIOID SETTLEMENT** 



- Screening for brain injury
- Supporting resource facilitation
- Ensuring that mental and behavioral health and substance use disorder providers are brain injury informed

Some States have provided funding to:

- Secure consultation and implementation of brain injury support, which will provide funding to access expert consultations or learning collaborations across state agency systems
- Support the specific needs of criminal-legal involved individuals with substance use disorder, including with brain injury resources
- Provide wrap-around services, including for people with brain injury

### American Rescue Plan Act -State Funding

State governments are allocated \$195.3 billion of this money. States have to allocate this money by December 31, 2024, and spend it by December 31, 2026. States can spend it in various ways, including but not limited to:

- Helping communities and households affected by the pandemic.  $\bullet$
- Paying essential workers extra money for the risks they've faced.
- Supporting programs or services for people who suffered because of the pandemic.
- Providing money for healthcare, preventing violence, and dealing with COVID-19.
- Giving more help to households, small businesses, and nonprofits.

Unless a State has allocated 100 percent of its funding, there may still be an opportunity to have this funding allocated to support brain injury programs and States have some flexibility in changing their plans.

#### State Examples:

- Addressing holistic approaches and violence prevention through mental health and substance abuse services, education, and job training and placement.
- Funding for the establishment of a training on trauma informed services as well as expanding access to services to children and families who are victims of severe trauma
- Funding for crisis intervention training and prevention on behavioral health
- Funding to nonprofits, such as Association/Alliances





### American Rescue Plan Act -Home and Community Based Services

Temporary 10 percentage point increase to the federal medical assistance percentage (FMAP) for certain Medicaid expenditures for HCBS

Deadline: March 31, 2025

States are required to submit an initial HCBS spending plan with semi-annual updates to CMS to receive federal approval for use of the increased funds for HCBS.

While states have received approval for their initial plans and the necessary state legislative authority for spending, they continue to navigate the process of updating proposals and distributing funds.

## Earmarks/ **Community Project Funding**

- Individual Members/Senators submit funding for governments & nonprofits. Funding is earmarked for a specific project.
- Certain "topics" that the project must be focused on.
- Average Award Size Last Year: \$2 Million, but different projects get different dollar amounts.
- Still competitive to receive the earmark; Members/Senators have limited amount they can submit. Not every member will submit earmarks
- Last year, deadlines were between April/May and guidance came out with only 2-3 week warning
- Community support is essential no matter the project. Members will look for things like: Broad coalition of support, articles/news about programs or projects, support from local elected officials, solid noncontroversial projects.
- Evidence of effectiveness also important. Scalability also a factor.





- Evidence-based substance use disorder and/or mental health treatment services.
- Improve or create new opportunities for older adults, individuals of all ages with disabilities, and their eligible family caregivers, to live independently and participate fully in their communities.
- Crisis Intervention Training
- Courts Training
- Other Community Development Programs




