### NIDILRR Plans Stakeholder Listening Sessions on Long-Range Plan

The Administration for Community Living's National Institute on Disability, Independent Living, and Rehabilitation Research (NIDILRR) is developing its 2024-2029 *Long-Range Plan* and wants to hear from stakeholders. Mandated by Congress to develop a Long-Range Plan every five years, the agency aims to continue to be responsive to the needs of key stakeholders — especially people living with disabilities. Stakeholders can provide feedback in two ways: Virtual listening sessions in August, September and October or by submitting written feedback by email, due November 2<sup>nd</sup>. Listening session will be held by stakeholder group via zoom.

Stakeholder groups includes: NIDILRR Grantees (Aug. 18); Disability Groups and Advocacy Organizations (Sept. 13); Individuals with Disabilities and Those Supporting Them (Sept. 28); Direct Service Providers and Non-NIDILRR Grantee Researchers (Oct. 12); General (Oct. 20 and Oct. 27). Stakeholder calls are scheduled from 1:00pm – 4:00pm (ET).

### HUD Awards Mainstream Vouchers to Help People with Disabilities with Housing

On July 27<sup>th</sup>, U.S. Department of Housing and Urban Development (HUD) announced the awarding of more than \$36 million for Mainstream Vouchers and additional administrative fees to 218 public housing agencies (PHAs) in 46 States to assist people with disabilities. Mainstream Vouchers help people secure housing in the community as they transition from institutional settings. Mainstream Vouchers are tenant-based vouchers that serve households that include non-elderly person(s) with disabilities, defined as any family that includes a person with disabilities who is at least 18 years old and not yet 62 years old.

Along with partners at the U.S. Department of Health and Human Services (HHS), HUD launched the [Housing and Services Resource Center \(HSRC\)](#), a one-stop shop for technical assistance, resources, and guidance, to support community-based housing for individuals with disabilities. PHAs and their partners are also encouraged to use the HSRC and to consider how expanded federal support and eligible uses of Medicaid Money Follows the Person Supplemental Services, as outlined in [this Notice](#) from the Centers for Medicare and Medicaid Services (CMS), which can also support the utilization of Mainstream Vouchers. A list of PHAs that received funding is available [here](#). HUD's funding award includes:

- **\$23 million** for 2,391 new Mainstream Vouchers that public housing agencies and disability networks and services partners can use to assist people with disabilities to transition from or avoid institutional settings or exit or avoid homelessness.

- **\$13 million** in additional administrative fees that help PHAs and their partners support tenants' housing search and navigation, fund landlord engagement activities, and cover other move-in costs.

Mainstream Vouchers, alongside HUD's Section 811 Project Rental Assistance program, is one of the most important federal programs that provide housing assistance to people with disabilities, including those transitioning to the community from institutional settings. The PHAs who administer Mainstream Vouchers locally coordinate with Centers for Independent Living, state protection and advocacy agencies, Medicaid agencies, homelessness Continuums of Care, and other agencies that assist people with disabilities to receive referrals, provide housing search assistance, and coordinate the provision of supportive services. #### **HHS' *Healthy People 2030* Includes TBI Objective**

The U.S. Department of Health and Human Services' *Healthy People 2030* includes a new objective to increase the percentage of adults who can resume more than half of their preinjury activities (with or without supports) five years after receiving acute inpatient rehabilitation for TBI. The objective points to the critical importance of access to inpatient rehabilitation and to community-based services and supports for people with TBI. The Office of Disease Prevention and Health Promotion's *Healthy People 2030* framework provides 10-year measurable public health objectives and tools to track the nation's progress toward achieving them.

Data from the NIDILRR-funded [Traumatic Brain Injury \(TBI\) Model Systems National Database](#) will serve as the approved data source for the [new core objective of Healthy People 2030](#). The TBI Model Systems National Database is the largest TBI longitudinal database in the world, with information on outcomes for individuals up to 30 years post-injury. #### **HRSA Awards Funding to Improve Healthcare**

On August 8, the Health Resources and Services Administration (HRSA) in separate announcements, announced that funding was awarded to: [Community health centers to advance health equity through better data collection and reporting](#) and to grantees to [expand health care capacity in rural and tribal communities](#) through health care job development, training, and placement. Nearly \$90 million in American Rescue Plan (ARP) funding was awarded to nearly 1,400 community health centers across the country to support a data modernization effort aimed at better identifying and responding to the specific needs of patients and communities through improved data quality; advancing COVID-19 response, mitigation, and recovery efforts; and helping prepare for future public health emergencies.

Nearly \$46 million in ARP funding will support 31 awardees to provide support for critical health workforce needs in rural areas such as dental hygienists, medical or dental assistants, community-based doulas, and other frontline health care workers. In addition, nearly \$10 million will support 13 organizations through the [Rural Residency Planning and Development Program](#) to establish new medical residency programs in rural communities to increase the number of physicians training in rural settings. In addition, nearly \$4 million will support 18 awards to improve patient health outcomes and quality and delivery of care throughout rural counties and improve access to care for rural veterans.

### **MSKTC Publishes Factsheet on Staying Healthy After TBI**

The NIDILRR-funded [Model Systems Knowledge Translation Center \(MSKTC\)](#) recently published a new resource for people with traumatic brain injury (TBI). A new study published in *The Lancet Neurology* demonstrates the ability of two blood-based biomarkers to predict how someone will recover from traumatic brain injury (TBI). ### NIDILRR-Funded Project is Conducting Survey on Health and Disabilities

The NIDILRR-funded project [Using the National Survey on Health and Disability Panel to Document the COVID-19 Pandemic Experiences of Working-Age Americans with Disabilities](#) is conducting the [2022 National Survey on Health and Disability \(NSHD\)](#) to understand how access to health care, insurance, and the COVID-19 pandemic may be affecting the lives of people with disabilities. The survey is open to US adults 18 years old or older, with any disability and any type of health care coverage, including no coverage. Individuals who identify as men or Black, Indigenous, or People of Color (BIPOC), and those who live in AR, DE, FL, GA, IN, KY, MS, OH, OK, TN, and TX are encouraged to participate. This is a multi-year survey and previous respondents are also encouraged to participate. Participants may also complete the survey by phone.
