Congress is Negotiating FY 2023 Omnibus Spending Bill

Today, Congress is negotiating the final omnibus spending bill to fund federal government beyond Fri., Dec., 23, when the continuing resolution is set to expire. Stay tuned for the details next week as NASHIA will send a *Capitol News* to report on fiscal year 2023 appropriations and other legislation that is attached to the spending bill.

ACL Plans TBI Partners Awareness Day on February 28

In observance of March Brain Injury Awareness Month, the Administration for Community Living (ACL) will be hosting a virtual Traumatic Brain Injury (TBI) Partners Day on February 28, 2023, 12:00 – 4:00pm (ET). Sessions are being planned featuring aging, employment, the intersectionality of TBI and other medical and social issues, and peer support. Plans are to include State and federal representatives, as well as people living with a brain injury and family members in the sessions. Session participants will be given the opportunity to ask questions during each session. There will be no cost to register for the event. Watch for upcoming details.

NIDILRR Center Seeks Input on Rehab Measures Database

The National Institute on Disability and Rehabilitation Research (NIDILR) -- funded [Disability and Rehabilitation Research Project on Knowledge Translation to Promote Patient-Centered Care Through Use of Standardized Assessments](#) seeks [input on updates to the Rehabilitation Measures Database](#). The [Rehabilitation Measures Database](#) is a searchable collection of summaries of more than 500 standardized assessments used in physical medicine and rehabilitation. The survey asks about experience with the database, how easy it is to use, and what additional features could be added to enhance its usefulness. Administration Announces Federal Plan for Ending Homelessness

On Monday, the Biden-Harris administration released a federal plan for ending homelessness in America that starts with the ambitious goal of reducing homelessness 25% by 2025. *All In: The Federal Strategic Plan to Prevent and End Homelessness* builds on the success of previous plans and to systemically prevent homelessness and combat the systemic racism that has created racial and ethnic disparities in homelessness. The plan was developed by the U.S. Interagency Council on Homelessness (USICH) and is a blueprint for States and local governments to use for creating their own plans to prevent and end homelessness and setting their own ambitious goals for 2025. The release of the plan coincides with the week of Homeless Person's Memorial Day, which commemorates the people who have lost their life while living without a home.

USICH and the White House also announced a [new initiative to help cities and States reduce unsheltered homelessness](#). The 19 federal agencies that make up USICH will work with select State and local governments to accelerate the implementation and effectiveness of strategies to get people off the streets and into homes. The [Department of Justice \(DOJ\)](#) has launched a new and improved [ADA.gov](#) designed to help expand access for people with disabilities and to serve the public more effectively. The updated website is written in plain language and includes easy-to-use navigation tools and overviews of featured topics, such as accessible parking, communication, and service animals, among others. The website also provides information about how to report a disability rights violation and the process for review and possible outcomes of a complaint.

On December 8th, the U.S. Office of Special Education and Rehabilitation Services (OSERS) introduced a new blog series that focuses on the discipline and behavior [guidance previously issued by OSERS](#). NHICM Foundation's Newsletter Focuses on Long COVID and Disability

The NHICM Foundation's Dec. 8th newsletter focuses on long COVID and disability. "Experts have referred to long COVID as 'the next public health disaster' and estimate the financial toll may have a \$3.7 trillion impact on the US economy. Last year, the [Department of Health and Human Services](#) (HHS) declared long COVID could be classified as a disability under federal law. However, there are gaps between [protections and accommodations](#) in the workplace and [barriers to disability benefits](#) for people with long COVID.
