### **Administration**

#### **Congress Approves CR to Keep Government Funded**

Yesterday, the Senate approved the Continuing Resolution (CR) which was first passed by the House of Representatives to fund the federal government through March 11. The previous CR ended at midnight tonight, thus the CR prevents a government shutdown. The measure now heads to President Biden's desk. As Congress has yet to pass spending bills, it has passed short-term CRs at the same funding levels as last year or referred to as level funding.

#### **ACL Announces New AoD Commissioner**

The Administration for Community Living (ACL) announced this week that Jill Jacobs is the new Commissioner for the Administration on Disabilities (AoD). Ms. Jacobs has more than two decades of professional experience managing disability services organizations, analyzing policy, and working toward improved health and disability programs and services at local, state, and federal levels. In addition, Ms. Jacobs brings to the role the lived experience of her own disability and as the mother of two disabled adults.

Before joining ACL, Ms. Jacobs served as the Executive Director of the ENDependence Center of Northern Virginia (ECNV), a center for independent living. Previously, Ms. Jacobs founded and served for sixteen years as the CEO of Ability Unleashed, a coordination and facilitation agency for Medicaid home and community-based services. She has held executive positions at several non-profit and government entities and served on the boards of a number of disability advocacy organizations, including the National Council on Independent Living and United Cerebral Palsy of Washington & Northern Virginia. For her work advancing rights and access of disabled military family members while she was an Army spouse, the United States Army awarded Jill the Dr. Mary E. Walker Medal of Honor. Ms. Jacobs is a graduate of Texas A&M at Central Texas and received social work training at Army Social Work Services at Fort Hood, Texas.

#### **Senate Confirms FDA Commissioner**

This week, the Senate confirmed Robert McKinnon Califf from North Carolina to be the Commissioner of the Food and Drugs Administration (FDA) within the U.S. Department of Health and Human Services. Yesterday, HHS Secretary released a statement welcoming Dr. Califf back to HHS as FDA Commissioner as he previously served in that position during the last year of the Obama-Biden Administration and as the agency's deputy commissioner of medical products and tobacco prior to that.

#### **NABMRR Posts Minutes from Their Meeting**

The minutes from the December 2021 National Advisory Board for Medical Rehabilitation Research (NABMRR) meeting have been posted on the NCMRR [website](#). Full videos of both

Legislation mandated that the National Institutes of Health (NIH) director establish the National Advisory Board on Medical Rehabilitation Research (NABMRR). The Board advises the directors of NIH, Eunice Kennedy Shriver National Institute of Child Health and Human Development (NICHD), and the [National Center for Medical Rehabilitation Research \(NCMRR\)](#) on matters and policies relating to NCMRR's programs. The Board comprises 12 members representing health and scientific disciplines related to medical rehabilitation and 6 members representing persons with disabilities.

#### **HUD Relaxes Spending Deadline for Emergency Solutions Grants**

The U.S. Department of Housing and Urban Development (HUD) is relaxing one of the deadlines in Notice CPD-21-08 for recipients to spend the CARES Act's Emergency Solutions Grants (ESG-CV), which can be used to provide urgent assistance to households experiencing homelessness during the COVID-19 pandemic. HUD is currently considering whether it is necessary to establish a later deadline to replace the March 31, 2022, deadline for expending 80% of each ESG-CV grant. HUD is also considering whether it is necessary to establish a new overall ESG-CV expenditure deadline that is later than the current September 30, 2022, deadline. #### **HSS Participates on Virtual Roundtable with Lawmakers on HCBS**

On February 17, 2022, U.S. Department of Health and Human Services (HHS) Secretary Xavier Becerra participated in a virtual roundtable with Senator Bob Casey (D-PA), Representative Debbie Dingell (D-MI), and other organizations on the need for Build Back Better's critical investments in Home and Community Based Services (HCBS). Secretary Becerra highlighted the importance of HCBS that make it possible for millions of seniors and people with disabilities and chronic illnesses to live in community and avoid institutions. He provided examples of actions HHS has taken over the past year to help strengthen the HCBS system, under the Biden-Harris Administration.

With funding from the American Rescue Plan, HHS was able to begin expanding HCBS, reauthorize the Money Follows the Person program, and provide guidance to States on receiving an additional 10 percentage point increase in HCBS federal matching funds, an estimated \$12.7 billion increase in federal spending nationally. HHS also began implementing the Medicaid HCBS Settings Rule, which defined and set standards for "community-based" for the first time and helps move state HCBS systems towards more individualized, smaller settings and away from larger congregate settings.

#### **HRSA Awards Funding to Health Centers to Increase Health Care Access**

On Monday, the Department of Health and Human Services (HHS), through the Health Resources and Services Administration (HRSA), awarded nearly \$55 million to 29 HRSA-funded health centers to increase health care access and quality for underserved populations through virtual care such as telehealth, remote patient monitoring, digital patient tools, and health information technology platforms. This funding builds on over \$7.3 billion in American Rescue Plan funding invested in community health centers over the past year to help mitigate the impact of COVID-19. #### **DETAC Reminds TBI Grantees of TA Opportunities**

The Disability Employment Technical Assistance Center (DETAC), funded by the Administration on Disabilities (AoD), reminds AoD grantees of upcoming opportunities to learn about assistive technology and other technical assistance opportunities. #### **ODEP Honors Black Leaders with Disabilities**

In celebration of Black History Month, Jennifer Thomas, policy advisor in the U.S. Department of Labor's Office of Disability Employment Policy, [posted a blog](#) on "Honoring the Contributions of Black Leaders with Disabilities." In the blog, she reflected on the importance of recognizing leaders with disabilities as part of Black history month. "This Black History Month, I encourage

you to learn more about them, especially those who worked to increase employment and economic opportunities for Black Americans, Americans with disabilities and others from historically marginalized communities," said Thomas. "Their stories inspire those of us in the Office of Disability Employment Policy to do what we do every month."

### **Biden-Harris Administration Announces RFI on Access to Medicaid and Chip**

As part of the Biden-Harris Administration's work to advance health equity and reduce health disparities, the Centers for Medicare & Medicaid Services (CMS) is seeking feedback on topics related to health care access, such as enrolling in and maintaining coverage, accessing health care services and supports, and ensuring adequate provider payment rates to encourage provider availability and quality. This Request for Information (RFI) is one of many actions CMS is taking to develop a more comprehensive access strategy in its Medicaid and CHIP programs.

Feedback obtained from the RFI will aid in CMS' understanding of enrollees' barriers to enrolling in and maintaining coverage and accessing needed health care services and support through Medicaid and CHIP. This information will help inform future policies, monitoring, and regulatory actions, helping ensure beneficiaries have equitable access to high-quality and appropriate care across all Medicaid and CHIP payment and delivery systems, including fee-for-service, managed care, and alternative payment models. The RFI submissions will also inform CMS' work to ensure timely access to critical services, such as behavioral health care and home and community-based services.

The RFI seeks feedback from a diverse set of stakeholders on a broad set of topics from ensuring adequate payment rates to encouraging provider availability and quality, to culturally and linguistically competent care and reducing gaps in health care coverage. Interested parties may access the RFI questions and provide comment on Medicaid.gov. The RFI is open for a 60-day public comment period beginning February 17, 2022.
