RSA Announces Real Pay for Real Jobs Initiative

The U.S. Department of Education's Rehabilitative Services Administration (RSA) has released the notice inviting applications for the Subminimum Wage to Competitive Integrated Employment (SWTCIE) demonstration project aimed at increasing access for people with disabilities to jobs that pay good wages. The SWTCIE project is the largest discretionary grant administered by RSA with \$167 million available to State Vocational Rehabilitation agencies and their partners. The new grant program will sponsor innovative approaches that allow people with disabilities to successfully secure jobs working alongside their non-disabled peers while earning the same pay.

The Notice Inviting Applications is available for [public inspection at the Federal Register](#). The *Federal Register* will publish the official version of the notice on Monday, March 21. The deadline for submissions is June 21, 2022.

U.S. AbilityOne Commission Drafts Strategic Plan

The AbilityOne Commission, an independent federal agency that administers the AbilityOne Program, is seeking public comment to its strategic plan published in the [Federal Register: Strategic Plan Notice](#). The purpose of the Commission is to provide employment opportunities for people who are blind or have significant disabilities in the manufacture and delivery of products and services to the federal government through the National Industries for the Blind and SourceAmerica. These agencies match government contracts with nonprofit agencies

across the country that train and employ people with disabilities. There are three overarching strategic objectives of the plan:

1. Expand competitive integrated employment (CIE) for people who are blind or have other significant disabilities.
2. Ensure effective governance across the AbilityOne Program.
3. Partner with Federal agencies and AbilityOne stakeholders to increase and improve CIE opportunities for people who are blind or have other significant disabilities.

HHS Announces Two Grant Programs for Opioid Use Disorder and Misuse of Prescription Drugs

On March 15, the Department of Health and Human Services (HHS), through the Substance Abuse and Mental Health Services Administration (SAMHSA), announced two grant programs totaling \$25.6 million that will expand access to medication-assisted treatment for opioid use disorder and prevent the misuse of prescription drugs. By reducing barriers to accessing the most effective, evidenced-based treatments, this funding reflects the priorities of HHS' [Overdose Prevention Strategy](#), as well as its new initiative to strengthen the nation's mental health and crisis care systems. The two grant programs are:

- The [**Strategic Prevention Framework for Prescription Drugs \(SPF Rx\)**](#) grant program provides funds for State agencies, territories, and tribal entities that have completed a Strategic Prevention Framework State Incentive Grant plan or a similar State plan to target prescription drug misuse. The grant program will raise awareness about the dangers of sharing medications, fake or counterfeit pills sold online, and over prescribing. The grant will fund a total of \$3 million over five years for up to six grantees.
- The [**Medication-Assisted Treatment – Prescription Drug and Opioid Addiction \(MAT-PDOA\)**](#) grant program provides resources to help expand and enhance access to Medications for Opioid Use Disorder (MOUD). It will help increase the number of individuals with Opioid Use Disorder (OUD) receiving MOUD and decrease illicit opioid use and prescription opioid misuse. The grant will fund a total of \$22.6 million over 5 years for up to 30 grantees. No less than \$11 million will be awarded to Native American tribes, tribal organizations, or consortia.

This grant program supports a comprehensive approach to addressing abuse in later life, including domestic violence, dating violence, sexual assault, stalking, neglect, and exploitation of victims who are 50 years of age or older. NCAPPS Schedules HCBS through the Lens of Person-Centered Practices Webinar

On March 31, 2022, the National Center on Advancing Person-Centered Practices and Systems (NCAPPS) will offer the webinar, "Understanding and Addressing Unmet Needs in HCBS; Through the Person-Centered Practices," from 3:00pm – 4:00pm (ET). While studies have found

a connection between unmet HCBS needs and adverse outcomes, including hospitalization, institutionalization, and death; few have examined user-reported perspectives about the quality and sufficiency of HCBS and their relationship to key health and community living outcomes. Researchers at the Lurie Institute for Disability Policy conducted a study to learn how many people who use HCBS need more services than they receive and understand the connection between unmet HCBS needs and health and community living outcomes.

Panelists will discuss what implications the results of the study have in regard to person-centered planning in HCBS, highlight opportunities for improvement, and discuss how to overcome challenges to advancing person-centered practices. Register [here](#).
