White House Hold Briefing on Saturday on Domestic Policy and Disabilities

DOL Reports February Job Numbers

Today, the U.S. Department of Labor (DOL) released the February jobs report that showed 678,000 jobs were added and that the unemployment decreased to 3.8. However, for people with disabilities, the *Monthly Update* (nTIDE) report, issued by Kessler Foundation and the University of New Hampshire's Institute on Disabilities, indicate that job numbers declined from 33.8 percent in January to 33.1 percent in February 2022 (down 2.1 percent or 0.7 percentage points. The report reminded readers that when looking at labor market statistics for people with disabilities that these statistics are based on a sample that is small relative to people without disabilities and, thus, subject to greater month-to-month variations.

CDC Adds IDD to List of Conditions at Increased Risk from COVID-19

The Centers for Disease Control and Prevention (CDC) updated its list in February with regard to people who are at elevated risk of severe disease from COVID-19. CDC has indicated that people with some types of disabilities may be more likely to get very sick from COVID-19 because of underlying medical conditions, living in congregate settings, or systemic health and social inequities. People with intellectual and developmental disabilities have been added to the list along with other types of disabilities.

HHS Appoints New Director of AHRQ

This week, U.S. Department of Health and Human Services (HHS) Secretary Xavier Becerra released a statement announcing the appointment of Robert "Bob" Valdez, Ph.D., MHSA, as Director of the Agency for Healthcare Research and Quality (AHRQ). AHRQ's mission is to produce evidence to make health care safer, higher quality, more accessible, equitable, and affordable, and to work within HHS and with other partners to make sure that the evidence is understood and used.

Reports and Resources

KFF Produces New Reports on Medicaid HCBS

The Kaiser Family Foundation (KFF) has produced two new resources: 1) "Medicaid Home & Community-Based Services: People Served and Spending During COVID-19," that reports State-level data on number of people served and spending on Medicaid HCBS in FY 2020; and 2) "State Policy Choices About Medicaid Home and Community-Based Services Amid the Pandemic." The Brief, published today, reported that most States report HCBS waiver waiting lists, totaling over 665,000 people nationally, though State variation in policies makes waiting lists an incomplete measure of program needs and State capacity, and waiting lists are not directly comparable among States or from year to year. The majority of people on waiting lists are in seven States that do not screen for waiver eligibility before placing individuals on a list.

Over half of States deliver some or all HCBS waiver services through capitated managed care.

GAO Issues Report on Abuse at Residential Schools and Other Similar Facilities

A new <u>report</u> from the Government Accountability office finds that local, State and federal agencies are not sufficiently coordinating their efforts to monitor residential facilities for young people with disabilities and those in foster care. The report, "CHILD WELFARE: HHS Should Facilitate Information Sharing Between States to Help Prevent and Address Maltreatment in Residential Facilities," was published after investigators interviewed officials in Arkansas, California, Massachusetts and Washington, D.C. responsible for overseeing residential facilities serving those in the child welfare system and residential schools paid for by Medicaid, the Individuals with Disabilities Education Act (IDEA) or other federal sources. They also spoke with stakeholder groups and examined State laws and regulations. GAO recommends that the U.S. Department of Health and Human Services (HHS), in consultation with Education, facilitate information sharing among States on promising practices for preventing and addressing maltreatment in residential facilities. HHS agreed with these recommendations. Read the report here.
