ACL Announces Virtual TBI Stakeholder Day

The U.S. Administration for Community Living (ACL) announced that a virtual TBI Stakeholder Day will be held on Tuesday, March 8, 2022 from 12:00pm – 4:30pm (ET) in observance of Brain Injury Awareness Month. Sessions will feature Survivor Engagement Strategies, Domestic Violence and the Effect on Children, Effective Partnerships with Behavioral Health with a Focus on Suicide, and Effective Strategies for Using and Leveraging Data. Issues of equity and intersectionality will be woven into each session. Additionally, participants will also hear from leaders at ACL, and other federal partners. ACL is in the process of finalizing the agenda. There is no cost to attend.

Administration Makes COVID-19 Tests, Face Masks and Vaccines Available

The federal government has announced a number of options for obtaining COVID-19 testing kits, N95 facemasks, vaccines and other assistance, particularly for individuals with disabilities. On Wednesday, the federal government launched a website for individuals to requests free home COVID-19 testing kits. Free tests (four per home) are available and may be requested by going to the website, COVIDTests.gov, or you may call 1-800-232-0233 or TTY: 1-888-720-7489.

The federal government is planning to send N95 masks across the country soon to community health centers and pharmacies. Some places will have them available late next week, with the roll-out expected to be completed by February. To learn more about effective masks and respirators, go to the Centers for Disease Control and Prevention's (CDC) website.

In addition, the Administration for Community Living (ACL) maintains the Disability Information and Access Line (DIAL) to help people with disabilities to:

- Help find local vaccination locations.
- Assist with making vaccination appointments.
- Help connect to available testing options, including help with ordering free at-home test kits.
- Connect callers to local services such as accessible transportation to overcome barriers to vaccination and testing.

The hotline also can provide information and resources to answer questions and address concerns about the vaccines and can connect callers to information and services that promote independent living and address fundamental needs, such as food, housing, and transportation. - Deaf and hard-of-hearing people can reach DIAL using the 711/Video Relay Service (VRS).

The DIAL information specialists are trained to work with people of various communications abilities, including spending as much time as needed to understand what they are saying. For people who do not communicate through speech, sign language or VRS, email is the best option to communicate with DIAL.

The Health Resources and Services Administration (HRSA) and the Centers for Disease Control and Prevention (CDC) launched a program to directly allocate COVID-19 vaccine to HRSA-supported health centers. This assistance includes the Health Center COVID-19 Vaccine Program, has begun incrementally at select HRSA-funded health centers that specialize in caring for hard-to-reach and disproportionately affected populations. The goal is to address health equity in vaccine delivery by providing a direct supply of COVID-19 vaccines to health centers who serve these populations. HRSA Awards Funding to Reduce Burnout and Promote Mental Health and Wellness Among Health Care Workers

Yesterday, the U.S. Department of Health and Human Services (HHS), through the Health Resources and Services Administration (HRSA), announced \$103 million in American Rescue Plan funding awards to improve the retention of health care workers and help respond to the nation's critical staffing needs by reducing burnout and promoting mental health and wellness among the health care workforce. These multi-year awards will fund evidence-informed programs, practices and training, with a specific focus on providers in underserved and rural communities.

HRSA is making these awards through three programs:

- Promoting Resilience and Mental Health Among Health Professional Workforce –
 HRSA is awarding \$28.6 million to 10 grantees to help health care organizations establish, improve, or expand evidence-informed programs and practices to promote mental health and well-being among the health workforce, including their employees.
- Health and Public Safety Workforce Resiliency Training Program HRSA is awarding \$68.2 million to 34 grantees to support tailored evidence-informed training development within health profession and nursing training activities. This curriculum will help reduce burnout and promote resilience among health care students, residents, health care professionals, paraprofessionals, trainees and public safety officers, such as firefighters, law enforcement officers, and ambulance crew members.
- Health and Public Safety Workforce Resiliency Technical Assistance Center HRSA is awarding \$6 million to George Washington University to provide tailored training and technical assistance to the awardees.

RSA Publishes FY 2022 MTAG and Announces State Reviews

On January 10, 2022, the U.S. Rehabilitation Services Administration (RSA) published the <u>FY 2022 Monitoring and Technical Assistance Guide (MTAG)</u>. The <u>MTAG</u> is intended to serve as a resource and planning guide for VR agencies and RSA to assist in the preparation for and conduct of monitoring and technical assistance activities in both program and fiscal performance focus areas with a goal of continuous improvement, taking into account the unique circumstances and needs of each VR agency.

On December 6, 2021, RSA announced the selection of twelve VR agencies for on-site monitoring and off-site reviews during federal FY 2022. The following VR agencies will be monitored on-site: Oregon Blind; Vermont General; Wyoming Combined; and Washington General. The following agencies will receive off-site reviews: Oregon General; Guam Combined; Maryland Combined; and Washington Blind. In addition, focused off-site reviews related to follow-up of corrective action plans will be conducted for: Florida Blind; Virgin Islands Combined; New Jersey General; and Maine General/Blind.

NHTSA Awards State Highway Safety Grants

Last month, the Department of Transportation's National Highway Traffic Safety Administration (NHTSA) announced the release of nearly \$260 million in highway safety grants. These grants, part of the funding included in the Bipartisan Infrastructure Law, were distributed to Highway Safety Offices in all 50 States, the District of Columbia, United States Territories, and the U.S. Department of the Interior's Bureau of Indian Affairs. The funds will help States and Territories support a broad array of traffic safety priorities. When full-year distributions are completed, the Bipartisan Infrastructure Law will increase the funding available for these vital life-saving programs by 31% over the previous fiscal year's levels.

The \$133.3 million in State and Community Highway Safety Program (Section 402) funds will enhance highway safety by supporting data-driven traffic safety programs in the States, such as high-visibility enforcement campaigns and other safe driving campaigns, as well as enforcement of and education about State laws on seat belt use and risky driving. In addition, the funding will help improve traffic records and support programs on the proper use of child safety seats, including inspection stations where caregivers can confirm the proper installation of their child safety seats.

NHTSA is providing an additional \$123.4 million to States and eligible Territories through the National Priority Incentive Programs (Section 405). These funds include nearly \$70 million for impaired driving countermeasures; \$19 million for State traffic safety information systems to help States build databases related to crashes; more than \$17 million for occupant protection including seat belt education and enforcement; more than \$9 million for distracted driving prevention; \$6.6 million for pedestrian and bicyclist safety programs; and \$2 million for motorcyclist safety.

This funding is part of over \$13 billion in funding for roadway safety programs in the Bipartisan Infrastructure Law, including a \$6 billion new Safe Streets for All discretionary grant program. The Department will release its first ever National Roadway Safety Strategy this month to lay out policies and issue a call to action to officials at all levels of government and stakeholders across sectors to help reduce traffic fatalities and injuries.

CDC Offers Three New Notice of Funding Opportunities, Includes Implementing mTBI Guideline

The Centers for Disease Control and Prevention's (CDC) National Center for Injury Prevention and Control (NCIPC), Division of Injury Prevention has announced three new notice of funding opportunities:

- RFA-CE-22-006 -- Research Grants to Evaluate the Effectiveness of Physical Therapy-based Exercises and Movements Used to Reduce Older Adults Falls. NCIPC intends support up to two (2) recipients for 3 years at up to \$350,000 per award per year. Application Due Date: March 1, 2022.
- RFA-CE-22-007 -- Reduce Health Disparities and Improve Traumatic Brain Injury (TBI) Related Outcomes Through the Implementation of CDC's Pediatric Mild TBI Guideline. NCIPC intends support up to one (1) recipient for 4 years at up to \$550,000 per year. Application Due Date: February 22, 2022.

• RFA-CE-22-008 -- Using Data Linkage to Understand Suicide Attempts, Self-Harm and Unintentional Drowning Deaths. NCIPC intends support up to two (2) recipients for 3 years at up to \$350,000 per award per year. Application Due Date: March 8, 2022.

HHS Announces Funding to Increase Behavioral Health Care Access in Rural Communities On Tuesday, the U.S. Department of Health and Human Services (HHS), through the Health Resources and Services Administration (HRSA), announced the availability of \$13 million in funding to increase access to behavioral health care services and address health inequities in rural America, including through evidence-based, trauma-informed treatment for substance use disorder.

HRSA's Federal Office of Rural Health Policy will make awards through the <u>Rural Communities</u> <u>Opioid Response Program (RCORP) - Behavioral Health Care Support</u>. Eligible applicants include entities such as Rural Health Clinics, federally recognized tribes, tribal organizations, and community- and faith-based organizations. Applicants can begin the RCORP-Behavioral Health Care Support application process on Grants.gov and must apply by Tuesday, April 19, 2022 at 11:59pm (ET). Federal Rules and Regulations

HHS Releases RFI for Electronic Prior Authorization Standards

The U.S. Department of Health and Human Services' (HHS) Office of the National Coordinator for Health Information Technology (ONC) today released a Request for Information (RFI) seeking input from the public on electronic prior authorization standards, implementation specifications and certification criteria that could be adopted within the ONC Health IT Certification Program (Certification Program). Responses to this RFI may be used to inform potential future rulemaking to better enable providers to interact with health care plans and other payers for the automated, electronic completion of prior authorization tasks.

Prior authorization requirements are established by payers to help control costs and ensure payment accuracy by verifying that an item or service is medically necessary, meets coverage criteria, and is consistent with standards of care. However, stakeholders have frequently noted that the processes associated with satisfying these requirements result in administrative burden for patients, health care providers, and payers. Diverse payer policies, workflow challenges, and technical barriers around prior authorization processes contribute to health care provider burnout, patient frustration and can even pose a health risk to patients when it delays their care.
